### **1. Spoke:**

- 1.1. Alexander Pichkunov with introductory speech.

### **2. Spoke:**

- 2.1. Alexander Pichkunov and David Pickthall with the proposals on entry of new organizations into KWU on different levels.
- 2.2. Antonio Pinero and Andrzej Drewniak with the proposals to increase the number of countries, which should have representatives of organizations wishing to join KWU, as well as to determine the minimum number of countries per continent; to specify in the protocol the need for the organization to have an official document confirming its registration as a sports organization.
- 2.3. Antonio Pinero with the proposal to draw up a unified contract for all small organizations that will work with KWU under the leadership of an international organization-founder. The organization-founder will represent the interests of the organization it has signed a contract with.
- 2.4. Hatsuo Royama with the proposal to admit to the KWU "KyokushinRyu" organization headed by Peter Chong.

**Decided:**

- 2.1. The document on the expansion of KWU adopted unanimously. An official protocol will be drawn up and sent to the representatives of the international organizations-founders, following which necessary amendments will be made.
- 2.2. To establish the following criteria for a potential KWU member organization: an organization must have representatives at least in 25 countries on 3 continents, with at least 3 countries per a continent. To specify in the protocol the need for the organization to have an official document confirming its registration as a sports organization. To specify in the document that an organization is eligible to participate in the qualifying tournaments only if it meets all the above-listed criteria and the founders unanimously admit this organization to KWU.
- 2.3. To draw up a unified contract for all small organizations that will work with KWU under the leadership of an international organization-founder. The organization-founder will represent the interests of the organization it has signed a contract with.
- 2.4. Unanimously decided to admit the organization of Peter Chong "KyokushinRyu" to KWU.

**3. Spoke:**

- 3.1 Hatsuo Royama with a proposal to give Ramil Gabbasov the right to appoint a KWU judge in a country who will be eligible to organize and conduct judging seminars according to KWU rules.

**Decided:**

- 3.1. To consult with Ramil Gabbasov on appointing a KWU judge in a country who will be eligible to organize and conduct judging seminars according to KWU rules.

**4. Spoke:**

- 4.1. Alexander Pichkunov with a proposal to appoint a major coach of the KWU at the 12th Open World Karate Championship.
- 4.2. Hatsuo Royama, Alexander Pichkunov and Antonio Pinero with the proposal to appoint David Picthall as a major trainer of the KWU team for the 12th Open World Karate Championship.

**Decided:**

- 4.1. Unanimously decided to appoint David Picthall as a major coach of the KWU team at the 12th Open World Karate Championship.
