The official judges will be selected on the side of KWU among the KWU accredited judges. The list of the approved judges will be published on the official website of the World Championship – www.kwu2019.com.

#### Awards

#### Conditions of summarizing the results

The kumite competition is a single-elimination tournament with elimination of the loosing competitor after one defeat. There will be two 3<sup>rd</sup> place winners in each weight category (no bouts for the 3<sup>rd</sup> place).

#### Awarding of champions and prizewinners

Champions and prize-winners (1<sup>st</sup> - 3<sup>rd</sup> places) are awarded with medals and diplomas as well as cups of corresponding grade.

#### **Anti-doping control**

Winners from 1<sup>st</sup> to 3<sup>rd</sup> places will go through the doping test in accordance with the rules of the World Anti-Doping Agency (WADA). The total number of samples is 60.

The competitors from WKO Shinkyokushinkai should contact their Branch Chiefs, who would inform the WKO Head office about their application for participation in the KWU World Championship.

### Requirements for the participants of the competition

For the credentials committee the team head should present the original of the application, and each competitor should have the following documents:

- passport;
- sports doctor's authorization as fit to compete (in English or Russian language), must be dated no earlier than November 6<sup>th</sup>, 2019;
- HIV antibodies test certificate (in English or Russian language), must be done no earlier than November 6<sup>th</sup>, 2019;
- HBV antibodies test certificate (in English or Russian language), must be done no earlier than November 6<sup>th</sup>, 2019;
- HCV antibodies test certificate (in English or Russian language), must be done no earlier than November 6<sup>th</sup>, 2019;
- Accident insurance valid at the time of the competition (original, in English or Russian language);
- written application form of a competitor Attachment №1;
- top of dogi and obi (belt);
- protectors (for women competitors).

### **Protectors:**

Each competitor admitted to competition should have:

- white dogi and obi (belt), that correspond to the competitor's qualification;
- individual groin cup (for men obligatory, for women optional);
- protectors for shin and insteps (for women obligatory);
- chest protector that meets the set requirements (for women obligatory);
- mouthguard of white color optional. For those who have brackets on teeth mouthguard is obligatory.

All protectors must have the KWU mark.

**ATTENTION!** Each competitor must have his or her own individual protectors!

### **Duration of bouts:**

#### Men:

Preliminary fights: 2 min. + 2 min. + 2 min.

Semi-final and final fights: 3 min. + 2 min. + 2 min.

Weight difference is not taken into account when the winner of the bout is being defined.
