## Meeting of the Executive Committee of Kyokushin World Union (KWU)

Date: 19.03.2021

Time: 13:00-14:00

### Agenda of the Meeting

1. To discuss the possibility of postponing the 5<sup>th</sup> KWU Kyokushin World Championship among men and women in weight categories that was scheduled for 2021 until 2022.
2. To discuss the possibility of holding the KWU European Championship among men and women in weight categories and the KWU World Youth Championship among boys, girls and juniors in December 2021.
3. About KWU as a co-founder of the KWU Professional League. The share in authorized capital is as follows: 40% for KWU; 60% for the KWU Professional League.
4. To recognize All-Russian Physical Culture and Sports Public Organization "Federation of Kyokushin of Russia" (President Mr. A.Alymov) as a KWU national federation in Russia.
5. To discuss the issue about the status of representatives of KWU national federations.

### **Decisions:**

1. To postpone the 5<sup>th</sup> KWU Kyokushin World Championship among men and women in weight categories that was scheduled for 2021 until 2022. To determine the exact after thorough examination of the epidemiological situation.
2. To support the KWU commitment to hold the KWU European Championship among men and women in weight categories and the KWU World Youth Championship among boys, girls and juniors in December 2021 , providing that epidemiological situation in Europe allows it.
3. To take note of the information that the share in authorized capital is as follows: 40% for KWU; 60% for the KWU Professional League.
4. 4.1. Shihan David Pickthall: The leadership of the IFK takes note of the information about a new federation of Kyokushin Karate under the leadership of Shihan Alymov in Russia.  
The leadership of the IFK does not object to this new federation establishing the KWU organisation in Russia as long as the equal rights for the athletes, coaches and judges of the IFK, as a founder member of the KWU are secured.

We ask you to consult on all the details about the observance of the equal rights of our members with the leadership of the IFK in Russia. Shihan Alexander Tanyushkin and Shihan Andrey Bura.

4.2. Shihan Antonio Pinero: To recognise All-Russian physical culture sports public organisation «Kyokushin Federation of Russia» (with the president A. N. Alymov) as a KWU national federation in Russia, which will represent the interests of KWU in Russia as long as the equal rights for the athletes, coaches and judges of the KWF are secured.

4.3. Kancho Hatsuo Royama: To recognise All-Russian physical culture sports public organisation «Kyokushin Federation of Russia» (with the president A. N. Alymov) as a KWU national federation in Russia, which will represent the interests of KWU in Russia as long as the equal rights for the athletes, coaches and judges of the KI are secured.

5. In the case of the creation of a national KWU federation in the country, in the absence of controversial issues, give the KWU National Representatives the appropriate status - KWU National Representative (name of the country).
